Section 172 Statement

In discharging their director's duties, the directors have adopted the group's governance framework and the interest of the group's stakeholders when taking decision. The directors also considered the relevant matters to the extent necessary for the understanding of the development, performance, position of the company. As an example, the directors considered matters of concerns to the wider stakeholders and the long-term sustainability of the company and the group as a guarantor of the group's refinancing arrangements during the year.
