## Section 172 Statement

The directors also considered the relevant matters to the extent necessary for the understanding of the development, performance, position of the company. As an example, the directors considered matters of concerns to the wider stakeholders and the long-term sustainability of the company and the group in respect in relation to its obligations under the Modern Slavery Act 2015 to publish an annual statement in respect of the steps taken to prevent modern slavery and human trafficking in its own business operations and supply chains.
